**Office Order**

Urban Development and Housing Department had awarded the **Tender no UDD/02(Ni Ko)/RE/3137** for “Selection of Software Development Agency for implementation of e-Governance project under JnNURM e-Governance in Municipality Project (With Pilot Project in Dhanbad Municipal Corporation) in Urban Development and housing department, GoJ” to **M/s Vayam Technologies Ltd.**

Department then entered into a contract on 14<sup>th</sup> of March 2016 with M/s Vayam Technologies Ltd based on the agreed upon terms by both the parties with the contract value of Rs 18,88,85,587/-

According to {**RFP Clause 3.4 Performance Security (Performance Bank Guarantee)**} M/s Vayam Technologies Ltd has to submit the Nationalised Bank Performance Bank Guarantee (PBG) of value of 10% of the contract value. At first they have submitted the Nationalised Bank PBG of Corporation Bank PBG serial no 248458 of Rs 1,88,85,586/- .And then after three months they have given a request letter on 27th July 2016 to change the Nationalized Bank Performance Bank Guarantee with the Private Bank (South Indian Bank Ltd). Subsequent to the same the request of the consultant was accepted.

M/s Vayam Technologies Ltd then submitted the South Indian Bank Ltd PBG No O726BG000142016 of amount Rs 1,88,85,586/-on 26/09/2016 and taken back the previously submitted PBG issued by Nationalized Bank (Corporation Bank)

On the process department found that the South Indian Bank Ltd is not a Nationalised Bank and issued a letter to M/s Vayam Technologies Ltd to submit a Nationalised Bank PBG (performance bank guarantee) of the said amount as mentioned in the contract via several letters vide RFP clause 3.4

- letter no 130 dated 30/01/2017
- letter no 250 dated 20/02/2017,
- letter no 280 dated 02/03/2017,
- letter no 460 dated 04/04/2017

In spite of repeated communication through the letters M/s Vayam Technologies Ltd has failed to submit the Nationalised Bank PBG (Performance Bank Guarantee). Lastly they have committed to submit the Nationalised Bank PBG (via letter no 41 dated 23<sup>rd</sup> May 2017) till 27/06/2017 but have failed. In response they have submitted the letter no vayam/SUDA/20062017 to extend the date of submission of Nationalised Bank PBG.

This shows the negligence towards the project as already committed by the Vendor. Even after reminding time and again repeatedly for 5 months they have not submitted the Nationalised Bank PBG. This shows the unprofessional approach of the vendor.


Consequently, violating the norms of contract agreement, the department is forced to take necessary actions against **M/s Vayam Technologies Ltd.** Hereby department has decided to debar **M/s Vayam Technologies Ltd** from participating in any tender or consulting assignment of Urban Development and Housing Department, Government of Jharkhand for the **next five years** from the issue of this order. This bears the approval of **Principal Secretary, Urban Development and Housing Department, Government of Jharkhand.**
